

General Instructions to the Candidate

1. Applicant can fill the Online Common Application Form on the website www.punjabpolicerecruitment.in from any Internet connected Computer.
2. Before starting to fill the online form, the candidate should have his/her personal working Mobile number. It is desirable that he/she should have his/her own email ID to enable fast communication.
3. Mobile Number & Email address can be used only once, same mobile number & email address cannot be reused for this post.
4. Scanned copies of the relevant documents may be required to upload them with the Application Form.
5. Due care and caution be exercised in filling up the Application Form.
6. The Application Form contains Six (06) Pages in all. You are required to fill in all the fields of all the pages in order to submit the Form successfully.
7. The candidates will submit their applications online on the Recruitment website of Punjab Police www.punjabpolicerecruitment.in.
8. Online submission of Application Forms on the Recruitment website of Punjab Police www.punjabpolicerecruitment.in will start w.e.f. 25.08.2016 09:00 a.m. onwards.
9. The candidate will be responsible to regularly check the latest information/updates from the recruitment website (www.punjabpolicerecruitment.in).
10. The candidate will be responsible for submission of any in-correct information in any form while filling the Application Form.
11. The Application process shall be available online only. The paper Application Forms are neither being printed nor being accepted.
12. Though the Application Form fields will be displayed in both english and punjabi, the candidate will be able to fill the Application Form only in english.
13. The Online Application Form has been designed in English and Punjabi for the

convenience of the candidates. However, if there is any variation in the interpretation of the words/instructions in both English and Punjabi, the English version shall prevail and the decision of Chairman of the Central Recruitment Board shall be final in this regard.

14. The candidate is advised to submit only single Online Application Form for the post of Constable as the Recruitment Process would start at all Recruitment Centres at the same time on the same date. However, if somehow, the candidate manages to submit multiple online applications, only the first Application shall be entertained and Fee paid against one Application Form shall not be adjusted against any other Application Form.
15. The candidate is advised to fill the Online Application Form personally or under his personal supervision if taking the help of any third party operator. The candidate will not be allowed to change the data entered in the Application Form once it is submitted and the same will be considered cancelled in case of any incomplete information. The candidate would be required to upload the scanned copies of required certificates.
16. Even in case the CAF is filled at the SAANJH Kendra/SUWIDHA Kendra, the responsibility about the veracity/correctness of the particulars entered will continue to be that of the candidate. Therefore, the candidate is advised to exercise due care and caution before submitting the CAF.
17. For all queries, clarifications or communications regarding the recruitment process, candidates are encouraged to correspond via email with helpdesk@punjabpolicerecruitment.in.
18. Individual messages to all candidates or to any defined group of candidates shall be sent from the Punjab Police SMS ID PPRECT, and individual email to all candidates or to any defined group of candidates shall be sent from the email ID info@punjabpolicerecruitment.in which shall be deemed to be valid communication between the Police Department and the candidate.
19. The candidate is advised to fill their relevant Category after due application of mind, as

the category once filled will not be changed thereafter.

20. A mere call for Physical Measurement Test, Physical Screening Test or the Interview-cum-Personality Test will not confer any right on the candidate for appointment to the post.
21. The candidate will bring all his/her original Educational Qualifications certificates alongwith category certificates as well as one (1) attested photo-copies of each certificate at the time of Interview-cum-Personality Test.
22. For claiming relaxations as above please consult Standing Order governing the entire Recruitment Process of Constables in Punjab Police, which will be available on the Recruitment website www.punjabpolicerecruitment.in.
23. Each candidate shall be given a unique Registration ID and once he/she completes the Registration Process. This Registration ID and Password should be used by the candidate for future access to the Application Form.
24. Last date for applying for the posts of Constables in Punjab Police is 05.09.2016 and only online applications would be accepted. Candidates can apply online till 11:59 p.m. on 05.09.2016.
25. However, the last date of fee deposit will be 07.09.2016.
26. Candidates already employed with the Govt can also apply for the recruitment after getting an NOC from the Head of Department/Office concerned. However, if the NOC is not available at the time of filling of the Application Form, then the candidate shall have to give a declaration to the effect that he/she shall produce the same in original at the time of Interview-cum-Personality Test.
27. Candidates are advised to go through the guidelines/instructions for filling in the application forms (online as well as Standing Order governing the entire Recruitment Process of Constables in Punjab Police), containing detailed criteria/eligibility conditions etc., which is available on the website.
28. The candidates can also download/print copies of the guidelines/instructions as well as the Standing Order from the Recruitment website of Punjab Police.

29. Candidate appearing for the PMT/PST/Interview-cum-Personality Test will not be eligible for any TA/DA.
30. The Bar – Coded Admit Card for the Physical Measurement Test/Physical Screening Test/Interview-cum-Personality Test will be made available via email which can be downloaded and printed.
31. Application Form will be liable to be rejected:
 - i. If the Application Form is incomplete;
 - ii. If it has been found to have been submitted without the requisite Application fees;
 - iii. If found without the supporting documents, and/or photograph and/or signatures;
 - iv. If it is found to be without the mandatory declarations.
32. The selection in the Recruitment Process shall be subject to the successful clearance in the Medical Examination to be conducted, character and antecedent's verification, and verification of the Educational qualifications Certificates from the concerned Boards/Universities.
33. Canvassing in any manner by the Candidate will be a ground for his/her disqualification.
